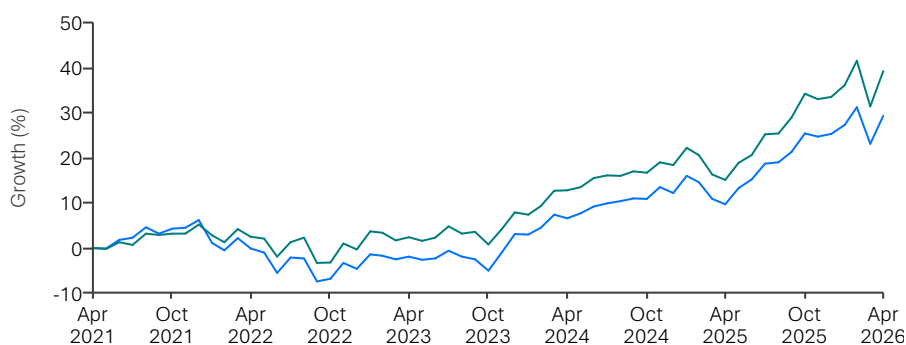


About the fund

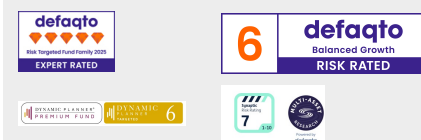
